Administrative History

The Loyola Center for Urban Policy (CUP) began in December 1979 and was phased out in 1988. During its nine years of existence, CUP gained a reputation for supplying timely and creditable research on practical, urban policy-oriented subjects. CUP was headed by Dr. Raymond Tatalovich, a professor in the political science department at Loyola University. As director, Tatalovich was involved from start to finish in accomplishing the center's objective: acting as a publishing agent for Chicago related research. Thanks to the hard work of Tatalovich and CUP, numerous studies were published, including *Alcoholism in the Urban Community* and *Homicide in Chicago*. Tatalovich summed everything up by saying "The center's interests are multi-disciplinary. We want to reach out to everyone who was something to say about urban life in Chicago."

Though funded by Loyola, additional operating expenses were generated by sales of CUP publications. Loyola ended funding for CUP in 1988.

Scope and Content

The Center for Urban Policy records consists of 1.5 linear feet spanning the years 1979 to 1988. These records include monographs, reports, and correspondence. The files are arranged alphabetically and the records within each file are organized chronologically.
